

#### Vision Statement


The **vision** of the NYSAC is that all New Yorkers will have improved experiences of healthcare, higher levels of health, and lower health care costs.

# Why the "Future of Nursing"?

How it Began....

## How it is Leading...

As the largest healthcare profession, nursing needs to play a pivotal role in transforming and sustaining a viable healthcare system. The *Future of Nursing - NYSAC*, a nonpartisan entity, is part of a broad national effort to implement the recommendations of the IOM Report. The responsibilities of the NYSAC are to:

- Engage a diverse group of stakeholders from a variety of sectors;
- Fashion a state-prioritized list of recommendations;
- Gain media exposure and build visibility/ awareness:
- Inform and educate policymakers and decision-makers on key issues;
- Outreach to philanthropies, businesses, and other entities for ongoing support

To facilitate efforts statewide, the NYSAC divided NYS into 7 regions:



In October 2010, New York State was designated as one of five initial pilot Action Coalitions to advance the Future of Nursing: Campaign for Action, a collaboration created by the Robert Wood Johnson Foundation (RWJF) and the AARP Foundation. NYSAC was created and in the first year a statewide inter-professional steering committee was assembled, priority recommendations were identified, a website was established, a part time project coordinator was hired with seed money, seven geographic regions for implementation activities were established and hundreds of individuals were recruited who wish to be part of this initiative. In December 2013, it was determined a volunteer subcommittee structure would help to expand the involvement of both nursing and non-nursing entities to assist in moving the agenda forward . Nearly 100 organizations have now signed on to support the work of the NYSAC.



The Institute of Medicine (IOM) report on "The Future of Nursing: Leading Change, Advancing Health" established eight recommendations to help guide the transformation of health care. NYSAC selected the following three recommendations as its priorities:



- #1: **Remove** scope-of-practice barriers so that advanced practice nurses can practice to the full extent of their education and training.
- #4: **Increase** the proportion of nurses with a baccalaureate degree to 80 percent by 2020 and increase the diversity of students to create a workforce prepared to meet the demands of diverse populations across the lifespan.
- #7: **Prepare** and enable nurses to lead change to advance health by assuming leadership positions across all levels of public, private and governmental programs.
