FEBRUARY 2020

New York / Vermont (NY/VT) Magnet Hospital Consortium met via WebEx with 31 participants. The meeting began with feedback from the American Nurses Credentialing Center (ANCC) October 2019 live Magnet Conference in Orlando, Florida. At the conference's Magnet Program Director (MPD) session Maureen Altieri, MS, RN, NEA-BC, Chairperson, NY/VT Magnet Hospital Consortium, was able to garner the consortium member's seats to sit together and network. Our member's feedback was that the session ran out of time to take questions. There was a Magnet Conference survey to provide feedback about the conference. Altieri had encouraged participation in the survey.

Difficult 2019 Magnet Application Manual SOEs were addressed by consortium members - SE8EO; EP21EO; TL8; SE9. All providing feedback and lessons learned.

ADAM (no cost) and ADAM plus (for purchase) was discussed. Formatting issues were evident with ADAM plus ANCC Magnet is working on this.

Needs Assessment Survey: Survey was sent and completed by October 26th, prior to the Consortium October 30th meeting. Members volunteered to participate in a 'Charter Review Workgroup,' 'Website Redesign Workgroup,' and 'Feedback On Your Journey.' Based on the needs assessment, the members would like to see items like challenging SOEs as an agenda topic. The members also indicated other ways that the consortium can meet the group needs: mentorship, networking, sharing best practices and ensuring inclusiveness of all consortium members.

ANCC Virtual Summit was on October 7th, and 8th, 2020. While there were some IT glitches, it was informative. The next ANCC Pathway to Excellence and ANCC Magnet Conference in-person (live) event has been rescheduled from May 2021 to November 11-13, 2021 in Atlanta, Georgia.
