Upstate University Hospital Who we Are

- We are a State Medical University comprised of both an Academic Medical Center with a Teaching Hospital at our Downtown Hospital and a Community Hospital with a total of **734** combined beds.
- We represent 45% of hospital beds in Syracuse and are considered the principle safety net provider in CNY.
- Level 1 Trauma Center, Golisano Children's Hospital, Designated Stroke, Burn and Poison Control Centers.
- We have over 79 specialty clinics
- Region's largest employer; nearly 9,900 employees and approximately 3000 of these are Registered Nurses
- We are a unionized environment!










Upstate University Hospital Journey to Magnet Designation....



- Never previously designated..
- We submitted our documentation on 10/1st!
- Received word on 2/5th that we had additional documentation requested
- We submitted the additional documentation on 7/15th
- We learned 9/3rd that we made it to site survey without any deficiencies
- We awaited word as to determine what the site visit options were-
- Identified 11/10th, 11/13th as our Magnet Survey
- 4 days, 4 appraisers, 10 hour/day schedules



Magnet Virtual Survey Lessons Learned

- Use the virtual platform as *an* **OPPORTUNITY**! rather than a barrier!!
- *Prepare* your internal stakeholders for a virtual process!
- Find your CIO & IMT stakeholders!
- Create a **PLAN B** (potentially PLAN C, D, E... etc..)
- Prepare for modifications PLAN A4, B8, ETC..
- Prepare **COMMUNICATION** PATHWAYS!
- Recognize, recognize, recognize- this was never the plan – but that is ABSOLUTELY where nurses rise!
